**Our Intent**

The Coconut Grove Village Council shall seek to promote and advance the interest of, and represent the people of Coconut Grove, Florida, before governmental and other entities having any impact on the people who live in the area defined herein as Coconut Grove.

The Council will seek to promote, protect, and preserve the social, economic, and physical environment and historic character of Coconut Grove and the interests of its citizens and, in doing so, follow Coconut Grove's tradition of cultural tolerance, respect for the natural environment, promotion of the arts, and commitment to social responsibility.

The Council Board shall be comprised of a total of nine (9) members elected by residents of Coconut Grove on November 2, 2021.

Each member of the Council shall be a registered voter and shall have resided within Coconut Grove (specifically within the boundaries of Coconut Grove defined by the City Commission resolution about this election of May 27, 2021) for a period of not less than 12 months prior to election or appointment as a Member.

Each elected member will be expected to participate in at least one of the Council's standing committees:

Transportation and Mobility  
Civic and Cultural Life  
Commercial and Retail  
Parks and Public Spaces  
Housing and Zoning
